WHEREAS, Bihar College of Education, Plot No. 375/166, 286/169(P), 375/165, Vill.- Gidha, PO.- Gidha, Tehsil/Taluka- Koilwar, Town/City-Ara, Dist.-Bhojpur, Bihar-802301 (Code No.ERCAPP790) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2012-2013 vide ERC Order No.13887 dated 31.08.2012, followed by revised order vide No.31680 dated 15.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 270th Meeting held on 25th 26th March, 2019 considered the matter along with the reply dated 02.03.2019 submitted by the institution in response to Show Cause Notice and observed as under:
 - (i) Show Cause Notice u/s 17(1) was issued on 22.02.2019.
 - (ii) The columns 15 & 16 of the faculty list not filled up, hence the same is deficient.
 - (iii) FDRs Rs.12 lakh (Rs.5 lakh + Rs.7 lakh) in joint mode are not submitted as per NCTE Regulations, 2014.
 - (iv) Fire safety certificate issued from the competent Govt. Authority not submitted.

In view of the above, the Committee decided as under: The Committee is of the opinion that recognition granted to B.Ed. course of the application bearing Code No.ERCAPP790 is withdrawn under section 17(1) of NCTE Act, 1993 with effect from the academic session 2019-2020.

- 3. **AND WHEERAS**, the order of withdrawal was not issued to the institution and the matter was re-considered by ERC in its 271st meeting held on 24-25 April, 2019 under the Agenda Item No.271.1.20 before confirmation of proceedings of 270th ERC meeting held on 25-26 March, 2019.
- 4. AND WHEREAS, the ERC in its 271st meeting held on 24-25 April, 2019 analyzed the representation vide Ref. No.BCE/791/19 dated 18.04.2019 along with enclosures submitted by the institution on the basis of decision taken in 270th meeting uploaded on ERC website and decided as under:

Decision taken by ERC for withdrawal of recognition to B.Ed. course is rectified and the recognition be restored from the academic session 2019-2020. Accordingly, order be issued to the institution and all concerned.

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

- 2. AND WHEREAS, the institution viz. Bihar College of Education, Plot No. 375-166, 286-169(P),375-165, Vill- Gidha, Po- Gidha, Tehsil/Taluka- Kollwar, Clty- Ara, Dist-Bhojpur, Bihar- 802301 was granted recognition as per Regulations 2009 for conduct of B.Ed. course of One year duration with an annual intake of 100 from the academic session 2012-2013 vide ERC order No. ERC/7-142.6.19/NCTE/B.Ed./ 2012/13887 dated 31.08.2012.
- 3. AND WHEREAS, the institution viz. Bihar College of Education, Plot No. 375-166, 286-169(P),375-165, Vill-Gidha, Fo-Gidha, Tehsil/Taluka-Koilwar, City-Ara, Dist.-Bhojpur, Bihar-802301 has by affidavit dated 13.01.2015 consented to come under New Regulations 2014 and sought for two basic units in B.Ed. course, which require additional facilities.
- 4. AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to fulfill following conditions namely,
 - (i) The institution shall create additional facilities that include (a) additional builtup area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committee with required documents by October 31, 2015.
 - (ii) The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection

- (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
